WHEREAS, the original Memorandum of Understanding between the Mohave County Board of Supervisors and the Presiding Judge of the Superior Court provided that the Committee on Court Automation "shall have thirteen (13) members all appointed by the Presiding Judge; a Chairperson who shall be the Presiding Judge of the Superior Court; a Vice-Chairperson who shall be the Mohave County Manager; a Secretary who shall be the Superior Court Administrator; a Treasurer who shall be the Mohave County Finance Director; the Mohave County Data Processing Contract Administrator; the Associate Presiding Judge; the Presiding Justice of the Peace; a representative from each participating City; and two (2) public members;" and


WHEREAS, the Superior Court intends to comply with this agreement in an effort to provide guidance and support in overseeing the Mohave County Court Automation Project;

IT IS ORDERED that the following membership changes are made to the Mohave County Committee on Court Automation:

1. Duc Ma, Mohave County Finance Director; Mike Matthews, Mohave County Information Technology Manager; Clyde Andress, Lake Havasu City Magistrate; Ruthie Teigen, Kingman Municipal Court Chief Clerk; and Doug Sutherland, Private Counsel are appointed as members of the above committee.
2. Linda Seapy, former Clerk of the Superior Court and Richard Scholz, Private Counsel, are removed as members of the above committee.
3. Gary Arend, Bullhead City Justice of the Peace; Paul Thomas, Justice Court Administrator; and Joe Clos, Court Automation Systems Manager are removed as members of the above committee but are appointed as advisors to the Committee.
4. Virlynn Tinnell, Clerk of the Superior Court, is appointed as an advisor to the above committee.

IT IS FURTHER ORDERED that these changes shall be effective the date of this order.
